We encourage you to fill in an application to celebrate a Nebraska school or school district with a strong commitment to arts education.

Applications are due on October 14, 2022.

The two winners will be notified on Monday, December 12, 2022, with celebration ceremonies taking place at each winner's school location in Spring 2023. Winners receive a special trophy and legislative resolution recognizing their achievement.

Grant Funding Available to Support the Arts in Juvenile Justice

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) at the U.S. Department of Justice recently released a funding opportunity, **Arts Programs for Justice-Involved Youth**, to directly support “high-quality arts programs for justice-involved youth to reduce juvenile delinquency, recidivism, and/or other problem and high-risk behaviors.”

The purpose of this funding is to **support and strengthen collaborations between arts-based organizations and juvenile justice systems to develop, expand, or enhance effective interventions that provide access to high-quality art programs with and for justice-involved youth.** Applicants may propose engaging youth at any point in the juvenile justice system, including alternatives to incarceration and diversion, secure detention and confinement, and strategies to support youths’ successful reentry into communities. **Eligible arts programs may include but are not limited to, painting, sculpting, drama, digital media, film, music, dance, singing, and creative writing.**

- This competitive grant opportunity is open to nonprofit organizations, local government units, and Native American tribal governments.
- Awards are up to \$66,500 with an 18-month performance period.
- There is no match requirement.

Applications are due by **July 18, 2022.**



Gallery 1516 is a non-profit art gallery in Omaha, Nebraska. Our mission is to support and celebrate Nebraska and regional artists from the visual arts, music, literature, and architecture. As part of our efforts to support Nebraska artists, Gallery 1516 developed the Nebraska Biennial exhibition in 2017. The goal of the Nebraska Biennial, which is held in odd-numbered years, is to create a showcase of the best artwork being created in the state.

After several years, Gallery 1516 has decided to widen the scope of this project by creating a complimentary exhibition: the Regional Biennial. In keeping with our mission to celebrate both Nebraska and regional artists, the Regional

Biennial offers an opportunity for artists from the Midwest region to show their work. This exhibition, held in even-numbered years, will focus on a specific medium each year. **The focus for 2022 is photography.**
