Nebraska Legislative Session Summary

The 108th Legislature, First Session, has adjourned SINE DIE. Nebraskans for the Arts focused on the following key bills this session:

LB605 – Art Therapy

NFTA **supported** LB605, which would provide protections and requirements for certified art therapists.

The bill advanced to General File but was not heard on the floor. We are hoping it will be heard next session.

LB371 – Prohibits people under 19 or 21 to attend a drag show

NFTA **opposed** this bill due its negative effects on the arts.

The bill did not move out of committee this session. NFTA is in close contact with national colleagues and are continuing to pro-actively monitor these types of legislations across the nation.



Creative Forces Grants Awarded to Nebraska Organizations

Two organizations from Nebraska are among the 34 organizations nationwide awarded a Creative Forces®: Community Engagement Grant. These community-based arts programming projects address the distinct experiences, challenges, and strengths of military-connected populations through the arts.

Congratulations to **BLIXT** and **West Nebraska Arts Center** who are the Nebraska recipients!

Creative Forces®: NEA Military Healing Arts Network is an initiative of the National Endowment for the Arts in partnership with the U.S. Departments of Defense and Veterans Affairs that seeks to improve the health, well-being, and quality of life for military and veteran populations exposed to trauma, as well as their families and caregivers.

These grants (totaling \$760,000) will serve a broad population, including active duty service members, guardsmen, reservists, veterans, military and veteran families, as well as caregivers and healthcare workers providing care for military service members and veterans.


