LB 605, Arts Therapy Certification

Art Therapists in Nebraska officially won licensure in our state after **LB605** was passed by the Legislature and signed by Governor Pillen on March 11, 2024.

Nebraskans for the Arts is still listening and engaging with our senators during these last few weeks of this legislative session. Most of the focus is on various tax bills that will have an indirect impact on the arts and arts education.

- LB1067 Inheritance Tax which could impact the use of Visitors Promotion/Improvement Funds still in first round debate.
- LB1412 and LB1413 State budget bills are moving to next round of debates.
- Tax rate bills must be passed by April 4th. If they
 do not fully fund the Governor's plan to reduce
 property taxes by 40%, he has indicated a special
 session will be called to continue the process.
