

Dear Respected Members of Nebraskans for the Arts,

Over this past year, it has been my pleasure to serve as your Executive Director. It has been a year of learning, meeting new people, and advocating for ALL of the arts.

During the NFTA 2023-24 fiscal year (July 1 to June 30), the NFTA Board of Directors conducted and adopted a new strategic plan, revised the association's by-laws, implemented a new membership CRM, and expanded our advocacy efforts through the Nebraska Arts Advocacy Network. We also celebrated the passage of LB605, the Arts Therapy Certification Bill.

In February, we were able to bring back the Arts Advocacy Day at the State Capitol, the first time since the pandemic. There was a record 130 people registered for this event including many representatives of the 30+ Creative Districts across the state. We are excited to have their advocacy voice.

Thank you for your continued support of NFTA and the arts and creative workforce in Nebraska.


- #1 Membership Engagement.

Mission

Advancing the arts as essential to life and learning for all Nebraskans.







Vision

- All communities offer professional arts experiences and every Nebraskan has the opportunity to be enriched by them.
- The arts are part of every child's basic education.
 Every Nebraska school has a comprehensive and sequential arts program for all students taught by certified teachers.





- The arts are perceived to be critical for a welleducated workforce and the state's economic prosperity. Nebraska's elected officials and business leaders invest public and private resources to support arts education and arts organizations.
- Nebraska is known for its many cultural opportunities and for a vibrant and creative environment that nurtures the development of students, artists, and arts organizations.

Advocacy Efforts

STATE:

LB605 Passes: As of March 11, 2024, art therapists in Nebraska are licensed. To become certified as an art therapist in Nebraska, an applicant must provide evidence to the Department of Health and Human Services.

LB1413 - NFTA opposed the sweeping redistribution of select funds. Although it did pass, there was a reduction in the amount of CCCFF funds that was swept and a commitment by the legislature to support grant payments for the FY24-25.

Advocacy efforts in the upcoming year will focus on expanding appropriations for arts grants and creative districts.

FEDERAL:

NFTA participated in the Americans for the Arts and Arts Action Fund Federal Advocacy Fly-In during the month of May. Areas of focus:

- FY24 Appropriations for National Endowment of the Arts and National Endowment for the Humanities
- Supporting Arts Education ESSA Title I, Title II, & Title IV, Arts Education for All Act (H.R. 5463) introduced by Rep. Suzanne Bonamici (OR-01), and Reimagining Inclusive Arts Education Act (H.R. 7261) introduced by Rep. David Scott (GA-13)

Executive Director Nielsen also met in person with U.S. Congressmen and Senators in Washington D.C. in June.








Nebraska Arts Advocacy Network

The Nebraska Arts Advocacy Network (NAAN) is a grassroots coalition of arts administrators, arts educators, artists, and arts enthusiasts committed to advocating for arts and culture across the state of Nebraska.
