Nebraskans for the Arts celebrates 40 years of arts advocacy.

In the spring of 1985, the Nebraskans for the Arts was formed as a 501(c)(3) nonprofit organization. The sole mission was to become the arts advocacy voice for the State of Nebraska. Representing arts organizations and individual members across the state, NFTA advises policymakers, elected officials, and community leaders on the importance of strong arts education in our schools, the economic impact of the arts in our communities, and the benefits of pro-arts policies for Nebraska.

Over the years, NFTA helped champion initiatives, some of which eventually became law A few of those advocacy efforts included:

- Support for the Nebraska Cultural Endowment (a one-of-a-kind private/public arts foundation)
- Advocated and Supported the creation of the State Fine Arts Standards with the Nebraska Department of Education in 2014
- Supported the Arts License Plate Initiative
- Advocated and Supported the Creative District Initiative
- Helped advocate the passing of the Arts Therapy Certification Bill

During this next year, we will reflect on our past as well as focus on our future. Advocacy for the arts and humanities is more important now than ever. Together, we can make a difference.

The 109th Legislature, First Session, will convene on January 8, 2025

The Nebraska State Legislature will include some new faces in the chamber this spring. NFTA is expanding our advocacy approaches to foster good working relationships with our elected officials and legislative staffs.

NFTA Nebraska Arts Advocacy Network. All of you are important in creating positive communications with our state senators. If you would like to be more involved, please consider being a representative for your legislative district on the Nebraska Arts Advocacy Network. NAAN members help champion the idea of sustained advocacy efforts by building relationships with their state senators, working together to resolve issues in their communities' arts sectors, and recruiting their friends and colleagues to engage in arts

advocacy efforts. We need your voice!

Nebraska Arts Action Fund. This sister arts organization has been around since the early 1990s. Originally called the Nebraska Citizens for Arts Education, it was reformed in 2011 as a 501(c)(4) and became the Nebraska Arts Action Fund. It has recently been reactivated, and we hope to have NAAF become yet another partner in promoting the importance of the arts. NAAF will share more about their efforts in the coming months.

Quorum. In partnership with Americans for the Arts, NFTA will be utilizing a new bill tracking and Action Alert system called Quorum starting in January. This new tool will be used to communicate with our NAAN members and NFTA Board Members when key aspects of legislation impacting the arts needs action.
