# National Arts Education Week, Sept. 14-20



In 2010, the U.S. House of Representatives passed House Resolution 275, which designated the week starting with the second Sunday in September as National Arts in Education Week. The purpose of the resolution is to celebrate the transformative power of arts in education for all students.



92% of American adults believe that it is important for students to receive an education in the arts (including dance, media arts, music, theater, visual arts, and literature): elementary school (92%), middle school (93%), and high school (89%). This sentiment crosses political party lines.



The Every Student Succeeds Act (ESSA) of 2015 lists the arts and music as part of a "well-rounded education," providing that all arts disciplines (dance, media arts, music, theatre, and visual art) are eligible for programmatic support through Title I, Title IV, and other supplemental federal funds available to school districts across the nation.

# **Advocacy at the Federal Level**

Congress is returning from the August recess and the first order of business will be federal funding. Both the House and Senate FY'26 Interior Appropriations bills could move to the floors of their chambers this month. These bills include funding for the NEA, NEH, and other cultural agencies as well as funding for arts education, but we expect floor amendments that could propose cutting or even eliminating this funding.

Federal cultural funding has a direct impact on every state and community. Cuts or rescissions don't just affect agencies in Washington—they reduce resources for organizations, artists, and schools in our state. That's why it's critical to be prepared.

Nebraskans for the Arts Executive Director Lance Nielsen and Neidy Hess, Communications and Grants Manager of the Omaha Conservatory of Music, were invited by Americans for the Arts to the July Advocacy Fly-in.

NFTA had private meetings specifically regarding NEA and NEH funding and grant rescissions, and requesting support for NEA and NEH in FY26 Appropriations.


